Cash, Checks, and E-Giving

In these rapidly changing times, cash and checks are rapidly becoming obsolete. This widespread trend has an impact on our parish. Banks, including ours, now prefer electronic “cashless” transactions.

In light of this remarkable change, we respectfully encourage everyone to consider using the “Bill Pay” service of their bank or credit union. This involves replacing cash or paper checks with an electronic check sent to St. Patrick Parish. Many already do this for their other recurring payments, such as cable TV, insurance premiums, and so on. It is a fairly easy process to add St. Patrick’s. Switching to electronic giving will help the parish in the four ways:

- Saving money by eliminating costly church envelopes.
- Making it easier to generate documentation for tax purposes.
- Simplifying the complex process of counting loose cash in the weekly collection.
- Providing a stable flow of income uninterrupted by vacations and bad weather.

At the moment, about 10% of our income arrives in our bank account in some electronic form. Please take a look at your current on-line “Bill Pay” options and consider helping our parish to adjust to the new ways of the banking system. Off with the veils!

Sooner or later "foreign" religions run into legal problems within democratic societies, especially regarding veils on women. The religious veil has been a flash point through the centuries, notably in France, Mexico, and Canada. In the view of militant secularists, veils should be banned because they signify the involuntary submission of women, inject religion into the public sphere, and defy the "host" culture's sensitivities. This anti-veil movement has a long history in the United States -- against Catholic nuns.

Here's an astonishing fact: In 1946, 36 of the 48 states had laws that prohibited Catholic sisters -- and anyone else -- from wearing veils in classrooms. Now and then, various parties challenged the constitutionality of the "veil bans," but in almost every case, state supreme courts upheld the laws. In 1951, for example, the Supreme Court of New Mexico justified the ban because the veil had a "propagandizing effect" on students. In other words, if young children liked their teacher who wore a veil, maybe this veiled religious "alien" would draw them away from their traditional American religion to a dangerous foreign sect, i. e. Catholicism.

In 1956, the most heated debate about veils occurred in North Dakota. The Supreme Court of North Dakota had finally invalidated the state's "veil ban," granting to Catholic nuns the right to wear the veil while teaching. Guess what happened. People demanded a state-wide referendum on the issue. At the ballot box, the majority of North Dakotans voted to overturn the court's ruling. Off with the veils!

Getting rid of the veil was never enough. Catholic nuns also had to be kept out of public schools. Why? Because they were not really loyal to the United States but to a foreign conspiracy based in Rome. For example, in 1952 a county court in Missouri ruled that sisters could never work in public schools. The court solemnly warned that sisters "act as instruments and agents of their religious orders, and engage in executing the policies of the Roman Catholic Church." Moreover, the court said that sisters, having taken vows of poverty and obedience, "cease to exist as free citizens and as individual economic units." To put it another way, nuns were just hapless victims of a male-dominated foreign religion that viciously exploited them.

These legal debates about religious veils may now seem astonishing. But they do remind us of our own troubled experience with foreign religions. Looking at the broader context, we also see a disturbing -- and perhaps prophetic -- pattern: fear of other religions tends to intensify among people whose own religion is declining.

Back in the 1940's and 1950's some Americans still believed that they could use legislation to thwart Catholicism, which many perceived as alien. Their efforts ultimately failed. And, irony of ironies, less than 10 years after the North Dakota referendum many Catholic nuns cast away their veils forever -- freely and eagerly. Anyone who tries to tame and control any religion will never win. Catholicism proves the point.
